The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches competing in that breed or variety.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for Best of Breed or Variety competition and that have been defeated in such competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

If the dog designated Winners Dog or Winners Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs that competed in the regular classes for its sex in calculating championship points.

After points have been computed for Winners Dog and Winners Bitch subject to the above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater. If no points are available for the Best of Winners, the number of regular class dogs in both sexes are added together and compared to the point schedule. If the total sum of regular class dogs and bitches meets or exceeds the number of competitors needed for one point in its sex, the Best of Winners will receive one championship point.

In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won under some other judge or judges than the two judges referred to above.

Division 3 is comprised of: District of Columbia, Kentucky, Maryland, North Carolina, Tennessee, Virginia, West Virginia.

**IRISH WOLFHOUND FOUNDATION (IWF) HEART STUDY - Sunday, April 2.** As part of the Life Cycle Study, the IWF will sponsor screening for cardiac health at the show site on Sunday, April 2. A donation of \$60 is requested for EKG/auscultation for hounds under 6 and \$30 for hounds 6 and older. Any hound found to have an abnormal EKG or auscultation will be worked into the echo clinic and a \$100 donation will be requested. Testing for OFA certification will be available but must be requested when you sign up. Echocardiogram/EKG (required for OFA cert.) will be \$200 for healthy dogs 2 years and under 6 year of age & \$100 for dogs over 6 years of age.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs Not Required for further judging will be excused.

Judges Are Not Required to Wait for Dogs. They will adhere as closely as possible to the Judging Program. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged. The PVIWC and the Show Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL Dogs present must be on leash or confined to their ex-pens/crates except when being judged or when in the exercising ring.

The Show Committee/Superintendent will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this show.

The Potomac Valley Irish Wolfhound Club (PVIWC), the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

MOVE-UP POLICY for the Specialty and Trials - PVIWC will permit a move-up to the next level class iaw AKC regulations. The request for a move-up must be made in writing and presented to the Show Secretary or Trial Secretary at least 30 minutes prior to the start of the specified evnt, show or trial. Move-up forms will be available at the Secretary's Table.

DECLINATION OF ENTRIES - The PVIWC may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes and no one shall have any claim or recourse against the Potomac Valley Irish Wolfhound Club, or any official or member thereof.

Vaccinations - Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. All dogs should have appropriate vaccinations, including those required by their home jurisdiction.

COVID GUIDELINES will be based on CDC and local recommendations at the time of the show and are subject to change.

PLEASE PICK UP AFTER YOURSELVES AND YOUR HOUNDS WHILE ON THE GROUNDS OF THE SHOW SITE AND THE HOTEL GROUNDS.

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- *Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.*
- *Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.*
- *Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.*
- *The sportsman judge judges only on the merits of the dogs and considers no other factors.*
- *The sportsman judge or exhibitor accepts constructive criticism.*
- *The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.*
- *The sportsman exhibitor refuses to compromise the impartiality of a judge.*
- *The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.*
- *Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.*
- *Sportsmen welcome, encourage and support newcomers to the sport.*
- *Sportsmen will deal fairly with all those who trade with them.*
- *Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.*
- *Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.*
- *Sportsmen always consider as paramount the welfare of their dog.*
- *Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.*

This responsibility is always at the forefront and is my motivation for promoting open communication, sharing information and ideas on the health and happiness of our beloved Irish Wolfhounds.

We own a mixed farm in Anglesey, an island off the coast of north Wales, with plenty of land to run our hounds. Sometimes we think that the hounds are our reason for keeping the farm although growing famous new potatoes and beautiful beef might add to that decision.

Roger and I had our first wolfhound, Eaglescrag Jess, in 1973 and started showing a year later.

We have been fortunate to have made up 18 UK champions since then; our first, Caredig Zoe, in 1989 and the latest, Caredig Destiny in 2021. All these were either bred by us or were by our stud dogs. Many of these stud dogs have been influential through producing champions in other people's kennels too and are to be found in many of the pedigrees around the world today. We have also bred 2 US champions, 2 in Finland and another in Italy.

I have judged specialties in Sweden, Denmark, Belgium, Canada and Germany as well as shows in Finland, Italy and Switzerland and, of course in Britain and Ireland.

The Irish Wolfhound Club, on whose committee I served for several years, voted me as their judge for the 1999 Championship Show and again in 2019. I have also judged the Canadian show in Thunder Bay as well as the Irish Wolfhound Club of Norway Specialty, Delaware Valley Show and Locust Grove in the USA.

My interpretation of the standard focuses on the belief that Irish wolfhounds are a beautiful, hunting breed at heart. I like them to be well proportioned but strong and, of course, look for easy active movement.

I am delighted to be judging the Potomac Valley Irish Wolfhound Show again. My first appointment with you was a memorable experience in 1999. As I am judging Crufts in March, it will be intriguing to compare the best of European hounds with yours only a month later.

I would like to thank the membership of the Potomac Valley Irish Wolfhound Club for inviting me to judge your Specialty show. I am looking forward to spending time with you and your hounds!

For the past 40 years I have shared my life with Irish Wolfhounds, experiencing the pleasure of their company as companions and as a breeder of Champion hounds who have won several top honors at our National and Regional Specialties. I am currently approved by the AKC to judge Irish Wolfhounds and Rhodesian Ridgebacks, having judged several RR parent club supported entries. It has been my privilege to meet and learn from our breed's most knowledgeable and talented people in the U.S., Canada and abroad. I was fortunate in my formative years to have been mentored by Bill and Betty Deemer "Fitzarran". I studied the breed for 10 ½ years before breeding my first litter. The dam of my first litter was Ch. Fitzarran Jade, Breed winner of the IWCA National Specialty in 1991. Carnasserie has incorporated the bloodlines from a limited number of other top producing kennels into my breeding program as well, still maintaining championship lines from my foundation bitch. Of the 12 Irish Wolfhounds currently living with me, four are 8th generation, one is 9th generation, three are 10th generation, and two are 11th generation grandchildren of Jade.

In addition to serving our national breed club, several regional clubs, health, education and rescue volunteer work, my desire to give back to the breed and the Irish Wolfhound community led me to apply for and become approved by the American Kennel Club to judge Irish Wolfhounds. Some of my past judging assignments have included the Sweepstakes classes for the Irish Wolfhound Association of the West Coast, the Potomac Valley Irish Wolfhound Club, the Irish Wolfhound Club of the Puget Sound, The Irish Wolfhound Club of America, the Irish Wolfhound Club of Canada, the Irish Wolfhound Association of New England, The BC branch of the Irish Wolfhound Club of Canada, all classes for the first Specialty Match for the Irish Wolfhound Association of the Greater Smoky Mountains, and the Irish Wolfhound Association of the Garden State Specialty match. It has also been my pleasure and honor to judge the the following clubs specialties; mid Canadian Regional Irish Wolfhound club, the Irish Wolfhound Association of the Garden State, the Northern California Irish Wolfhound club, the 14th Irish Wolfhound Club of Russia's National Specialty, the Irish Wolfhound Club of America's National Specialty, Rocky Mountain Irish Wolfhound Association, the Irish Wolfhound Club of Northern Ireland, Irish Wolfhound Association of New England, Irish Wolfhound Association of the Puget Sound, IWADV supported entry at the Bryn Mawr KC and the Irish Wolfhound Association of the West Coast.

I served 7 years on the board of the Berger Picard Club of America as its treasurer and currently hold the position of its AKC delegate, having been so for the past 5 years.

Irish Wolfhound Breed Standard

General Appearance - Of great size and commanding appearance, the Irish Wolfhound is remarkable in combining power and swiftness with keen sight. The largest and tallest of the galloping hounds, in general type he is a rough-coated, Greyhound-like breed; very muscular, strong though gracefully built; movements easy and active; head and neck carried high, the tail carried with an upward sweep with a slight curve towards the extremity. The minimum height and weight of dogs should be 32 inches and 120 pounds; of bitches, 30 inches and 105 pounds; these to apply only to hounds over 18 months of age. Anything below this should be debarred from competition. Great size, including height at shoulder and proportionate length of body, is the desideratum to be aimed at, and it is desired to firmly establish a race that shall average from 32 to 34 inches in dogs, showing the requisite power, activity, courage and symmetry.

Head - Long, the frontal bones of the forehead very slightly raised and very little indentation between the eyes. Skull, not too broad. Muzzle, long and moderately pointed. Ears, small and Greyhound-like in carriage.

Neck - Rather long, very strong and muscular, well arched, without dewlap or loose skin about the throat.

Chest - Very deep. Breast, wide.

Back - Rather long than short. Loins arched.

Tail - Long and slightly curved, of moderate thickness, and well covered with hair.

Belly - Well drawn up.

Forequarters - Shoulders, muscular, giving breadth of chest, set sloping. Elbows well under, neither turned inwards nor outwards.

Leg - Forearm muscular, and the whole leg strong and quite straight.

Hindquarters - Muscular thighs and second thigh long and strong as in the Greyhound, and hocks well let down and turning neither in nor out.

Feet - Moderately large and round, neither turned inwards nor outwards. Toes, well arched and closed. Nails, very strong and curved.

Hair - Rough and hard on body, legs and head; especially wiry and long over eyes and under jaw.

Color and Markings - The recognized colors are gray, brindle, red, black, pure white, fawn or any other color that appears in the Deerhound.

Faults - *Too light or heavy a head; too highly arched frontal bone; large ears and hanging flat to the face; short neck; full dewlap; too narrow or too broad a chest; sunken or hollow or quite straight back; bent forelegs; overbent fetlocks; twisted feet; spreading toes; too curly a tail; weak hindquarters and a general want of muscle; too short in body. Lips or nose liver-colored or lacking pigmentation.*

List of Points in Order of Merit

Typical. The Irish Wolfhound is a rough-coated Greyhound-like breed, the tallest of the coursing hounds and remarkable in combining power and swiftness.

Great size and commanding appearance.

Movements easy and active.

Head, long and level, carried high.

Forelegs, heavily boned, quite straight; elbows well set under.

Thighs long and muscular; second thighs, well muscled, stifles nicely bent.

Coat, rough and hard, especially wiry and long over eyes and under jaw.

Body, long, well-ribbed up, with ribs well sprung, and great breadth across hips.

Loins arched, belly well drawn up.

Ears, small, with Greyhound like carriage.

Feet, moderately large and round; toes, close, well arched.

Neck, long, well arched and very strong.

Chest, very deep, moderately broad.

Shoulders, muscular, set sloping.

Tail, long and slightly curved.

Eyes, dark.

Note--The above in no way alters the "Standard of Excellence," which must in all cases be rigidly adhered to; they simply give the various points in order of merit. If in any case they appear at variance with Standard of Excellence, it is the latter which is correct.
